Social Workers Convene Today In Louisville

Educators and heads of institutions from all sections of Kentucky will convene Thursday morning at the Brown Hotel to participate in a two day session of the Kentucky Conference of Social Work. The conference will be opened at 9 o'clock with an address of welcome by Mayor William B. Harrison.

Other principal speakers on the opening day will be: Gov. Flem D. Sampson and John P. Haswell, Chairman of the State Board of Charities and Corrections. They will address the delegates at a public dinner to be given at the hotel at 6:30 o'clock. William N. Beehler, president of the Kentucky Conference of Social Work will preside.

Discussions of Kentucky's feeble-minded, insane, delinquents and criminals will be held at the morning and afternoon sessions. Speakers on these subjects will include Dr. A. M. Lyon, superintendent of the Feeble-minded Institute, Frankfort; Dr. Fred J. LaRue, superintendent of the Eastern State Hospital, Lexington; Dr. A. T. MacCormack, secretary of the State Board of Health, Louisville; Warden H. M. Beard, State Reformatory, Frankfort and J. C. Bird, Commissioner of Public Institutions, Frankfort.

Judges Involved In Dry Muddle At Washington

THREE NEWSPAPER REPORTERS
JAILED BY COURTS BECAUSE
THEY REFUSE TO NAME
BOOTLEGGERS

Washington, Oct. 30.—Hysteria over law enforcement in the District of Columbia, resulting from hectic police developments of recent weeks and President Hoover's demand that the Capital be made "the model city of the land," has now put members of the Federal Judiciary in strenuous and conspicuous positions. As usual prohibition enforcement, or rather the lack of it, is part of the background. Today Peyton Gordon, one of the Justices of the Supreme Court of the District of Columbia, sentenced to jail for forty-five days each three Washington newspaper reporters who refused to give to a grand jury names and data concerning liquor law violations, uncovered for the Washington Times. Gordon declined to release the men—Gorman M. Hendricks, Linton Burkett and Jack Nevin, Jr.—under bond pending an appeal. Each man formally declined to give the information sought.

SCHEDULE OF BRIDGE TOLLS

As appears on the statement furnished us by the committee having in charge the management of the Municipal Bridge, the schedule of tolls is as follows:

- Pedestrians five cents, no commutation tickets to be sold.
- The toll for passenger automobiles and vehicles drawn by horses is the same whether occupied by the driver alone or any number of persons up to and including seven.
- Toll for passenger automobiles thirty-five cents.
- Vehicles drawn by one horse, fifty cents.
- Vehicles drawn by two horses, seventy-five cents.
- The toll for busses including all vehicles with a seating capacity for more than seven persons and all busses operated by a bus line with not less than six in operation, and making not less than four thousand crossings a month, fifty cents.
- Any other bus (including one with a seating capacity for less than seven persons) \$1.00.
- For commercial vehicles the toll is regulated by the tonnage of the trucks, for one of a ton or less, thirty-five cents, and gradually increasing to ten tons with a maximum of a toll of \$1.50.
- Vehicles drawn by a single horse, fifty cents.
- Vehicles drawn by two horses, seventy-five cents.
- Vehicles drawn by four horses, one dollar.
- Horse and rider, or horse lead across, fifty cents.
- No driven animals will be permitted to cross the bridge.
- Other vehicles, requiring survey, special price.
- Vehicles propelled by man power such as bicycles, push-carts, wheel-barrows, etc., will not be permitted to pass over the bridge excepting that a bicycle rider may dismount and cross.
- Commutation tickets for those using the bridge frequently and regularly will be sold at the administration building a book of 25 for passenger automobiles or motorcycles at \$5.00 each. The tickets are subject to the conditions upon which they are sold, (which conditions are not set forth in the schedule.)
- No commutation tickets for any other class of traffic will be issued.

NORTHERN INDIANA CITIES DEMANDING RUM CLEAN-UP IN ELECTION NOVEMBER 5

U. S. Prohibition Expose Is Issue Of Hot Campaign This Fall Up State.

Demands for cleanups in northern Indiana are featuring many of the campaigns for municipal offices to be filled in the elections on Nov. 5.

The federal investigation into booze and vote crimes, which has resulted in the indictment of many politicians and bootleggers, has furnished plenty of material for reform candidates. The offices to be filled at the elections include in all the Indiana cities the mayor, councilmen, city judge, city treasurer, and city clerk.

Details Of Campaign
The candidates for mayor in the principal northern Indiana cities and some of the issues in the campaigns follow:

Gary—Roswell O. Johnson, Republican, a former mayor, who was convicted of federal offenses and then unconditionally pardoned by President Coolidge, is opposed by Emmet N. White, Democrat, a lawyer, Johnson, whose chief support comes from the forces of Ralph D. Bradford, new political boss of Gary, seeks vindication of his name. White calls upon the voters to "clear the fair name of Gary."

East Chicago—Mayor Raleigh P. Hale, Republican, one of those new under-federal indictment for conspiracy to violate the prohibition law, is finishing his first term. He will be arraigned in federal court on Nov 4 and run for re-election on Nov. 5. His

Hoover To Blame For Stock Crash Democrats Assert

ROBINSON SAYS COOLIDGE,
HOOVER, MELLON BROUGHT
ON SLUMP BY CHEERING
STATEMENTS

Washington, Oct. 31.—Democratic leaders and allied groups opposing the Hoover Administration are now bent upon blaming the administration for the stock market debacle. Such a trend has been noticeable for several days, but it was not until today that the attack was given definiteness by a statement issued through the Democratic National Committee by Senator Joseph T. Robinson of Arkansas, Senate minority leader.

Robinson flatly accuses President Hoover, Secretary Mellon and their advisers of failing to take adequate steps to prevent a collapse by which "millions of small investors lost their resources and are involved in bankruptcy and ruin."
